No work is to be commenced until permission has been granted by the Corporation and all required permits have been issued. Premature commencement of work shall be deemed a breach of the Proprietary Lease and House Rules and will result in a fine \$1,000 and possible legal action.

## 1. INSURANCE

Prior to the commencement of the Work, Shareholder will procure from the Shareholder's contractor or contractors and deliver to the Management Office, the insurance policies described below. Such policies shall provide that they may not be terminated until at least ten (10) days after written notice to the Corporation. All policies or certificates evidencing the issuance of the same shall be (a.) with companies that are reasonably acceptable to the Corporation and (b.)delivered to the Corporation before the Work commences.

- a. Comprehensive General Liability insurance policy, for personal injury and property damage in an amount not less than \$1,000,000, combined single limit which policy names the Corporation, the managing agent, and the shareholder as additional insures.
  - Along with the certificate of insurance, Shareholder shall furnish a contractor's endorsement from the contractor's policy authorizing the naming of the additional insures.
- Workers' Compensation and employer's liability insurance policies, covering all employees of the contractor or subcontractor.
- c. Automobile liability policy covering bodily injury and property damage in the amount of not less than \$1,000,000, combined single limit with the same additional insured information as in (a) above.
